2 (Following recitation of the
3 Pledge of the Allegiance, the meeting
4 was called to order.)

5 MR. MCGINTY: The first public
6 hearing is entitled
7 Mortgage-In-Default Registry. The
8 purpose is to control and try to
9 eliminate those deteriorating and/or
10 dilapidated properties within the
11 confines of the Incorporated Village
12 particularly with foreclosures. So
13 we will have a Registry, we will be
14 charging for that Registry, and
15 moving forward on that.

16 Ladies and gentlemen, I got the
17 support of the building inspector,
18 John Rocco, and we will go forward if
19 there is no questions from you, okay.

20 At any point, if the public
21 wants to ask questions, please. So
22 that first public hearing, does
23 anyone want to ask any questions
24 about the Mortgage Registry?

25 THE PUBLIC: (No comment.)

2 MR. MAYOR: So the second
3 hearing is the Contractor Cement
4 Truck Wash Down. We are going to
5 update filing fees, add the
6 requirement to notify the building
7 department, and file an affidavit
8 stating receipt of Local Law. If
9 Rolland, as an example, if Rolland is
10 doing concrete work, he has to let
11 the Village know a day ahead of time.
12 We have to protect our drains.

13 TRUSTEE NAUDUS: It can't just
14 be Irene driving around texting the
15 Mayor saying they are pouring cement
16 down this block.

17 MR. MCGINTY: Well, those who
18 work earlier calling and saying, do
19 you know what they are doing on such
20 and such street.

21 MR. ZIMATORE: For what it's
22 worth. My name is Roland Zimatore;
23 185 Suffolk Road. When I had done
24 the work at my house two years now
25 with the cement, I posted the letter

2 right up there, laminated it, and
3 everything else. And they dug a
4 hole, there is a hole in my property,
5 and poured everything into that hole
6 and broke it up later and got rid of
7 it.

8 MR. MCGINTY: That's exactly
9 what they are supposed to do. Thank
10 you.

11 TRUSTEE NAUDUS: We are just
12 trying to enforce that because some
13 people were not doing that.

14 MR. ZIMATORE: All right.

15 MR. MCGINTY: And then the last
16 is I presented a Tentative Budget to
17 the Village Board. That Tentative
18 Budget is last year's approved
19 budget. What I've asked the Board to
20 do is sit down independently and
21 review and comment. They know, as
22 you will know right now, that we are
23 restructuring debt service and we are
24 looking to upgrade our bond rating
25 moving forward. Are there any

3 THE PUBLIC: (No comment.)

4 MR. MCGINTY: So the hearings
5 are closed. While I'm thinking about
6 it, April 8th, 7:00 p.m.?

7 MS. CONROY: That's good.

8 MR. MCGINTY: April 8th, 7:00
9 p.m., I will be at the library and I
10 will be discussing HMPG and
11 associated projects. For the record,
12 before the Trustee reports, I want
13 the record to reflect that there have
14 been individuals who have commented
15 in a disingenuous manner. Everybody
16 in their grandmother knows I teach on
17 Tuesday nights. I contacted Ms.
18 Ambrosio, I contacted Ms. Rothman of
19 the Civic Association, and I
20 requested, I indicated to them that I
21 couldn't get out of teaching, I
22 couldn't take off. I asked them to
23 reschedule a meeting for me and I
24 will be glad to speak to any and all
25 comers.

2 Now, those of you that know me
3 know that I will talk about the
4 Village from sunrise to sunset
5 anywhere, anytime. I mean, I have
6 turned into a one-trick pony, you
7 know.

8 TRUSTEE NAUDUS: And you
9 offered to do it on speaker phone,
10 Mayor. You did tell them that if
11 they wanted to speak with you that
12 you would do it on speaker phone and
13 they did not respond to that.

14 MR. MCGINTY: Oh, that's right.

15 MR. ZIMATORE: I was there and
16 I heard that, too. Oh, really, they
17 are asking for trouble now.

18 MR. MCGINTY: Also, everybody
19 has my cell phone number and it's not
20 like --

21 MR. ZIMATORE: And somebody had
22 said if anybody wants to speak to
23 Mike, his cell phone, if anybody
24 needs his cell phone, so I was there.

25 MR. MCGINTY: That's all I can

3 the response to civic action.

4 TRUSTEE NAUDUS: April 8th.

5 MR. MCGINTY: Yes, April 8th,
6 7:00 p.m. at the library. I thought
7 instead of using the Village Hall, I
8 would use the library because I
9 really thought that people might be
10 more comfortable. It's a little more
11 central and truthfully it doesn't
12 seem as -- it seems more personal at
13 the library than here. And they even
14 know that I'm going to be at the
15 12:15 mass on Sunday, but that's
16 enough of that. So can we do our
17 reports, please?

18 TRUSTEE GAGLIARDI: Ready?

19 MR. MCGINTY: Yes.

20 TRUSTEE GAGLIARDI: For the
21 month of February, the fire
22 department responded to 61 alarms; 36
23 rescues; 1 auto accident; 3 signal
24 lines/second single lines; 3 aided
25 members, rescues with ambulances,

2 they were with the engine and ladder,
3 12 of those; Mutual aid fires, 2; and
4 1 silent alarm requested. Grand
5 total of 61 alarms for the month of
6 February.

7 MR. MCGINTY: Trustee
8 Gagliardis?

9 TRUSTEE GAGLIARDI: Yes.

10 MR. MCGINTY: What happened on
11 the corner or near the corner of --
12 was it Brighton and Madison?

13 TRUSTEE GAGLIARDI: I don't
14 know all of the particular details.
15 I understand this individual was
16 openly burning, so I don't know what
17 he was burning.

18 MR. MCGINTY: Oh, okay.

19 TRUSTEE GAGLIARDI: He was
20 using an open fire pit and using
21 other materials with it. And several
22 of the other local residents around
23 that area were calling. So I don't
24 know all of the particulars. I
25 understand the fire marshall attended

2 last night to that alarm to that
3 address.

4 MR. MCGINTY: Thank you.

5 TRUSTEE GAGLIARDI: For the
6 Fourth Precinct this month, they had
7 5 arrests; 30 parkers; 3 movers; 28
8 aided cases; and no burglary/robbery
9 to report for the month.

10 MR. MCGINTY: Thank you.
11 Trustee Volpe-Reid, please.

12 TRUSTEE VOLPE-REID: Good
13 evening. The Masone Beach will be
14 open for the Village's Annual Easter
15 Egg Hunt on Sunday, April 14th from
16 1:30 p.m. for all ages. Easter Egg
17 Hunt flyers can be picked up at the
18 Village Hall.

19 We are currently in the process
20 of creating our schedule for events
21 at Masone Beach, which will include
22 our Pre-Prom party in June for all
23 students attending their High School
24 Prom, and Summer Concert and Movie
25 Series. Dates have not been

8 As always, we will update our

11 MR. MCGINTY: Thank you.
12 Trustee Naudus.

16 if I don't remember, I have to look
17 and see about that foundation. That
18 foundation at 28 Sagamore concerns

18 MR. MCGINTY: Before you go any
19 further. Irene has watched between a
20 175 and a 180 homes here in the
21 Village lifted on monolithic
22 foundations and she tracks them.
23 It's no joke that I make a comment
24 that she is driving around the
25 Village early in the morning. She

2 has also watched and we have also
3 watched an average of one solar
4 insolation a month around here.

5 Now, keep in mind what that
6 means. We have a housing stock of
7 1200 homes. To be exact, it's 1144,
8 but we are at 15 percent lifted. We
9 are at 1 percent of -- actually, now
10 it's 2 percent. 2 percent of our
11 homes have solar insulations. Yes,
12 we are moving ahead. Thank you.

13 TRUSTEE NAUDUS: Now I'm going
14 to do the Code Enforcements. For the
15 month of February, we had 58 expired
16 meters; we had 30 backed into stall;
17 we had 58 no parking permits; 1 left
18 to curb; 1 blocked driveway; 1
19 blocked fire hydrant; alternate
20 parking, 68; inspection over 60 days,
21 10; restricted parking, 14; others,
22 10; expired registrations more than
23 60 days, 6; out of stall, 12; bus
24 stop, 1; blocking driveway, 1; 12inch
25 to curb, 1; inspection 60 days, 13;

2 expired expiration or registration
3 over 60, 15. All with a total of 303
4 tickets with a value of \$15,585.

5 MR. MCGINTY: God bless the
6 fines. Did our code enforcer let you
7 know that he is going to start the
8 overnights last night and tonight.
9 We are starting the overnights now as
10 we are trying -- it's an example of
11 preventive maintenance. Start them
12 now, let everybody know, no
13 foolishness at night. And not only
14 the undercover officers, but also our
15 own people, no foolishness.

16 Public Works?

17 Trustee VOLPE-RIED: Public
18 Works Report. The following was
19 collected in February:

20 173.26 tons of municipal solid
21 waste;

22 7.88 tons of mixed glass.

23 All street lights and meters
24 that were reported not working are
25 being repaired. All the Village

2 owned property is being maintained.

5 MR. MCGINTY: Thank you.

6 TRUSTEE VOLPE-RIED: You're
7 welcome.

8 MR. MCGINTY: Madam Clerk,
9 would you read the roll? We read the
10 roll before the public hearing and
11 then for the regular meeting.

12 TRUSTEE NAUDUS: You don't want
13 to do your report?

14 MR. MCGINTY: No, I don't want
15 to do my report. They find that I
16 can stay here all night and will. We
17 are making progress on all of our
18 projects. If you have specific
19 questions, please feel free.

20 MR. ZIMATORE: Any update with
21 the storm piping and our \$40 million?

22 MR. MCGINTY: Yes, two parts.
23 Madam Clerk did the RFP for dry flood
24 proofing at the firehouse. I did the
25 RFP for Design and Engineering under

2 the direct supervision of the
3 government and with help from Nassau
4 County DPW. Between us, we saved the
5 Village conservatively \$125,000,
6 which will roll back into the
7 project. The Design and Engineering
8 results will be back to us mid-May,
9 give or take, and we will go from
10 there.

11 I remember the design phase in
12 the first-phase, we cleaned all the
13 drains when they expected us to clean
14 17 percent. We cleaned all the drain
15 boxes when they expected 10 percent.
16 We turned back \$1,140,000, we run the
17 budget, and that included the
18 containment area under direct DEC
19 supervision. That 1.1 million has
20 been rolled into the phase and keeps
21 rolling because they appreciate our
22 budgetary concerns, our Fiscal
23 Constraint.

24 We did a model study. We now
25 have a complete map of all of our

2 drains and drain boxes, and they have
3 all been cleaned. And we are about
4 to do field examinations as the
5 weather breaks on the drain boxes
6 and some of the drains as we move
7 forward.

8 Secondly, we partnered with the
9 Town of Hempstead on, well, a project
10 cleaning drains. Through a grant,
11 it's the two of us, the Village and
12 Town, and we are buying a Guzzler
13 Truck, it's the industrial model for
14 cleaning drains and drain boxes.

15 TRUSTEE GAGLIARDI: A vacuum.

16 MR. MCGINTY: Yes, exactly. So
17 that's already been ordered. Deputy
18 Comptroller Ramos ordered it.
19 Truthfully, neither one of us had to
20 put up any cash. And, yes, you are
21 going to say to me, yeah, but there
22 is a Maintenance of Effort going
23 further, yes. And Congresswoman Rice
24 has indicated she is going to help us
25 with that through EPA filings.

2 Because remember -- Roland, knows
3 this better than anybody -- we can
4 install these new Tideflex valves,
5 but we have to do the maintenance and
6 plan the maintenance for those
7 Flex-Valves as well as the drains.

8 And what we will be doing with
9 the EPA is laying out a long-term
10 schedule of maintenance. So well
11 after Roland and I are in a nursing
12 home, there will be a schedule of how
13 to maintain these.

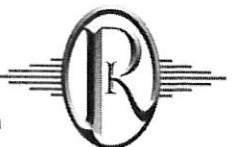
