24 titled Health/Dental insurance, Part A  
25 titled Retiree Health Coverage, of the

3 2021, was revised to state:

4 Health/Dental Insurance, Section  
5 A, Retiree Health Coverage.

6 The Village of Island Park agrees  
7 to continue to pay the full cost of  
8 each retired employee's Health  
9 Insurance and Dental for the Plan now  
10 in effect, who retired prior to  
11 July 15th, 2021, the date of the prior  
12 revision to the Employee Handbook and  
13 to future retirees with (10) ten years  
14 of service hired prior to the date of  
15 this Employee Handbook's revision,  
16 including all increases in premium.

17 The Village of Island Park agrees  
18 to pay eighty percent (80%) of the  
19 cost of each employee's Health  
20 Insurance and Dental for the Plan now  
21 in effect for all full-time employees  
22 hired after the date of this employee  
23 Handbooks's adoption, with (10) ten  
24 years of service, including all  
25 increases in premium payments. Each
