22 immobilization and removal of
23 illegally parked vehicles, vehicles
24 with delinquent tickets and

2 park car: Any motor vehicle park
3 of left standing upon any
4 Village-owned property, public
5 street or highway of the Village of
6 Island Park in violation of an
7 ordinance or regulation issued by
8 an agency authorized to promulgate
9 parking ordinances and regulations.

10 Immobilize/immobilization: The act
11 of placing on a parked motor
12 vehicle a mechanical device known
13 as a boot, designed to be attached
14 to the wheel or tire or other part
15 of such vehicle so as to prohibit
16 its usual manner of movement.

17 Delinquent: A parking ticket,
18 warrant or summons that that has
19 not been answered by the required
20 appearance date of for which
21 adjudged fines and applicable
22 surcharge shave not been paid in
23 the amount of \$300.00 or more.

24 Removal: Act of towing a parked
25 motor vehicle, which shall be

2 placed and stored in a location
3 designated by the Village and shall
4 be held until its released or
5 disposed of pursuant to applicable
6 law.

7 MAYOR MCGINTY: Motion to open
8 the hearing. Mr. Zimatore, it's

12 going to pull in and see everybody.
